Please see my responses to the questions you asked in the email.

I have a few questions that are popping to mind as I review documents from Itasca ISD.

- 1. Did you happen to report your concerns with the Chapter 313 Agreement contract and delayed construction/operation of the Files Valley Solar farm to the Texas Comptroller's Office? No, I did not make any contact with the comptroller's office. At the time I made the request and even at this time there are questions regarding who has the final authority and jurisdiction regarding Chapter 313 agreements. I and other taxpayers are currently pursuing this matter. There are questions regarding the relationship between landowners, school officials, public leaders and solar companies whose signatures are on the contracts that have been signed to date. Our concerns and steps taken have not been made known publicly at this time. One other issue regarding the comptroller's office is their position on Performance Contracting. The comptroller's office has refused to answer letters and request going back many years pertaining to several of the school districts where fraud and corruption has occurred with bad energy contracts. As I mentioned in previously fraud and corruption is widespread regarding Performance Contracting. At this time, I would rather not discuss anything with them. The comptroller's office is one of the agencies in Texas being called out in the cases we are pursuing in court.
- 2. I recall you mentioning that you were not allowed to speak at Board Meetings. Is that accurate? If so, please provide details regarding your attempts to speak during Public Forum and the District's denial of that request. On April 10th, I attended a board meeting to ask the board specific questions pertaining to the Chapter 313 agreements that were signed by district leaders. My attempt to ask questions and receive answers were completely shut down by the board. The board has not been cooperative from the beginning and when the first requests were made to gain copies of the information regarding the energy contract, they signed in 2016 with I-Deal Impact. At this time Mr. Stevens was still the superintendent at the district.
- 3. On May 1, 2023, you signed a USPS Certified Mail Receipt confirming you received the District's request for clarification to your April 13, 2023, open records request mostly related to Chapter 313 Agreements. Did you submit to the District the clarification that was requested? If so, please provide documents relate to your reply. I did not respond to the letter that was sent. At that time, I was still gathering more information pertaining to the (3) Chapter 313 agreements. After talking to many other taxpayers regarding a district's ability to enter into and sign contracts worth \$965 mil dollars without the public even knowing it is happening has gained the attention of many taxpayers. Due to the arrest of Mr. Stevens on June 1st and the changes in the district taxpayers have delayed our challenges with the district until we have consulted with legal counsel to represent us.

I will be meeting and talking with lawyers over the next couple of weeks regarding Chapter 313 agreements executed by other districts in Hill County. It appears on the surface school boards lack the knowledge and experience to negotiate the terms of these contracts. The Itasca ISD has left hundreds of millions of dollars of eligible taxable property value(s) from solar farms on the table and have not fairly represented the taxpayers of the district. Because these contracts and negotiations are not made public through the media or papers taxpayers do not even know what is going on. I have talked to dozens of taxpayers in Itasca and not a single person even knew what I was talking about! School districts have too much power and control regarding school finances and taxpayer money.

I have been researching and studying the statutes that pertain to Chapter 313 agreements. It is very clear the Itasca ISD did not know how to bargain fairly for the taxpayers of their district. It appears the landowners and solar companies are the ones who came out on top. We are also finding out other districts in several counties have followed suit with Itasca ISD.

What we are trying to stop is school districts from leveraging school bond programs with projected tax revenues from solar farms that are years away from being completed like the Itasca ISD has done. I spoke with the Hill County tax appraiser Mr. Mike Mckibben last week and at this time it appears not a single penny has been collected from a solar farm in Hill County to date. It will most likely be 2024 before tax revenues are realized. What the Itasca ISD advertised in 2021 and 2022

regarding the bond program was based on speculation and a contract that expired in December 2021.

I hope this information answers your questions. Please contact me if you need anything else or I can help.


