

Taxpayers Ramp Up Legal Challenges after the 89th Legislative Session Comes to and End

The Public Education System of Texas has Suppressed and Trampled the Freedom and Liberties of Citizens of Texas and Enslaved Them with the Bond of Unlawful Taxation for Decades!

Taxpayers are taking the next steps regarding multiple criminal lawsuits against dozens of school districts in the north Texas area. The criminal complaints filed in February and March are being amended and now will be filed with the FBI as directed by the DOJ in addition to the complaints filed with the DOJ and SEC. Over the past five years the groundwork has been underway to bring legal challenges against school district administrators and board members for fraud and corruption regarding school finances and bond programs that have bankrupted tens of thousands of taxpayers and homeowners.

The current 89th legislative session coming to an end has given taxpayers all the ammunition needed to hold state lawmakers and school official accountable for their collaborated efforts working in unison to defraud the citizens and taxpayers of Texas. State leaders and local school officials have tried to put taxpayers in deeper debt using covert and diversionary tactics to distract the general public from what really goes on in Austin. While school board meetings are conducted behind closed doors across the state a growing group of citizens and taxpayers are zeroed in to expose fraud and corruption costing taxpayers hundreds of billions of dollars in fraudulent bond packages and annual school budgets.

School districts across the state started months ago to put forth the bond referendums on May 3rd worth billions of dollars. These bond referendums are based on nothing but pure speculation and guesswork by local school officials, architects and contractors all working in unison to defraud taxpayers. The advertised impact to taxpayers by local school superintendents and board members are based on deception and speculation and nothing else. While local school districts are guilty of fraud and corruption lawmakers in Austin have been working to make things even worse for naïve and misinformed taxpayers. The increase in the homestead exemptions for homeowners will lead to even more pain and suffering for many homeowners and taxpayers when the tax burden for current and new bond referendums is shifted to a smaller group of homeowners. The increase in the homestead exemptions has nullified all the bond referendums that passed on May 3rd. The math and numbers used hoodwink taxpayers will now be used as evidence in court to expose the fraud and deception by local school officials.

The newest lawsuits being filed will be in regard to the school voucher bill and law passed by lawmakers and signed by Governor Gregg Abbott. The new voucher program is nothing short of legalized discrimination against children and their families. The state of Texas has categorized

children with a monetary value and worth not to mention used them as a pawn to boast a political victory.

Taxpayers have pressured lawmakers to repeal property taxes in favor of a uniform sales tax to fund public education to spread the cost and burden of education fairly across the general population of taxpayers.
